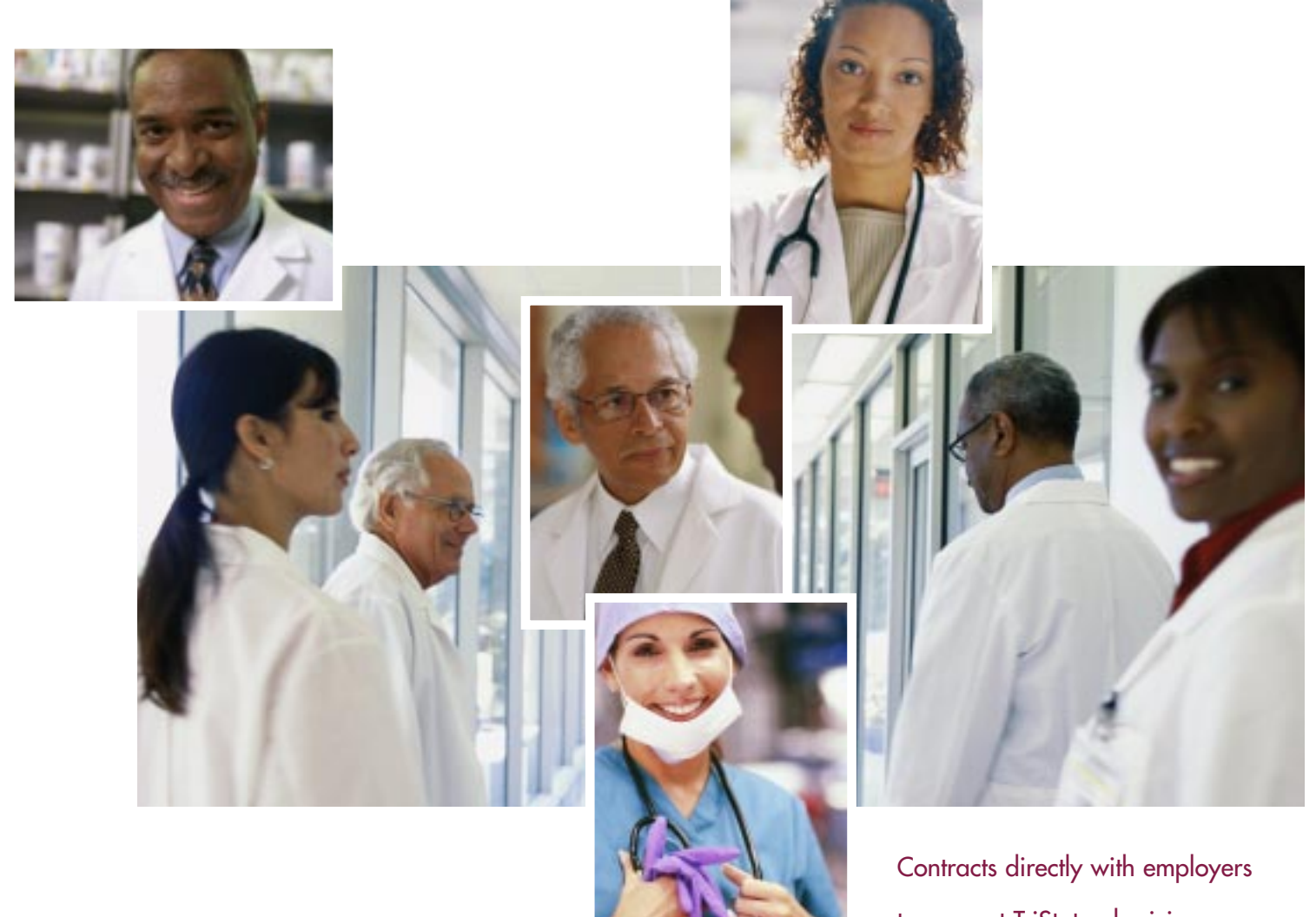

Initiated in 1991 by 3 Cincinnati based hospital systems, HealthSpan is now the leading provider-owned and independent network of hospitals, physicians, and ancillary services in the TriState region. The network includes 100% of area hospitals and 98% of area physicians. HealthSpan is owned by Mercy Health Partners of Southwest Ohio and Catholic Healthcare Partners.

Serving employer groups which are either self-funded or fully-insured, HealthSpan continues to grow and is the leading independent PPO network competing with the three national carriers in the Greater Cincinnati market. In addition, HealthSpan sets itself apart through its ability to offer comprehensive products and services including wellness, EAP and care management programs.

HealthSpan Complete Care

HealthSpan partners with physicians to deliver a comprehensive care management program. The HealthSpan Complete Care mission is to promote and improve the health of our population and to empower members to be appropriate users of healthcare by providing the tools and resources that will engage them in the process of lifestyle, health, and healthcare self management. Our goal is to support early identification of health issues and encourage members to take an active and informed role in managing their health and healthcare decisions. HealthSpan does not retain a percent of savings, 100% of savings is passed on to the employer.
